### The Redding / Shaw Weekly Quiz

#### Week 8

This quiz is being provided on a weekly basis to promote robust crew discussions and further individual rules study. It is in no way intended to be official play interpretations, as those are contained within Part II of the 2019 NCAA Football Rules, and are updated by official CFO Play Interpretation Bulletins when released during the season. These quizzes will be released on Wednesday of each game week, with answers being provided on the following Monday.

Answer each question by giving **THESE FOUR ITEMS** of information for the **next time the ball is to be put in play**:

**Team in possession**

**Down and distance (or Free Kick or Try)**

**Yard line of succeeding spot**

**Game clock status (Ready/ Snap / Running / FK Rules / No Clock / 10-Second Runoff)**

For any fouls that are not offset, assume that the penalty is accepted unless it is declined by rule, including accepting a 10 second subtraction if it is available.

1. A, Try, B-3. B25 intercepts a forward pass in the end zone and returns to the B-15 where he is tackled. During the return B66 clips in the end zone.

2. A, 4/7, B-45. B63 clips at the B-32 while the punt is in the air. Punt receiver B21 catches the kick in his own end zone and retreats across the end line.

3. A, 2/30, A-30. After A22 takes a handoff at the A-28, B95 grabs and twists his facemask, causing him to fumble at the A-35. End A80 recovers at the A-40 and is tackled at the A-45.

4. A, 3/6, 50. A12 throws a legal forward pass that hits guard A67 in the back of the helmet. Eligible A88 catches the ball and is tackled at the B-47.

5. Team A has 2<sup>nd</sup> and five at the B-10. A32 carries to the B-6 where he is hit and fumbles the ball across B's goal line. To prevent A81 from recovering the ball, B47 bats it across the end line.

6. Team A has 4<sup>th</sup> and 10 at the B-45. A3's punt is touched first beyond the neutral zone by A85 at the B-15, and then B21 picks up the kick at the B-10 and advances it to the B-20 where he fumbles. B44 recovers the fumble while grounded at the B-25. During the kick, B36 holds A17 at the line of scrimmage.

7. Team A has 2<sup>nd</sup> and five at the A-45. A12's pass is complete to A82 at the B-30 where he is tackled. B27 is flagged for defensive pass interference, and Team A initially declines the penalty. Video shows that A82 stepped on the sideline and returned inbounds before the pass was thrown. Replay stops the game for review.

8. Team A's free kick from the A-35 is fielded by B24 at the B-10 and returned to the B-30 where A81 brings him down with a horse collar tackle. Video shows that B24 had a foot on the sideline when he first touched the ball at the B-10. Replay stops the game for review.
